



**Fees for Periodic Safety Update Reports submission of Veterinary Medicines approved by National, Mutual Recognition or Decentralised Procedures or PSURs under WorkSharing Project**

The Portaria n.º 27/2011, from 10<sup>th</sup> January, has updated and adapted the fees for acts relating to the procedures concerning veterinary medicinal products, in order to allow, as soon as possible, real costs convergence.

According to this Portaria (point 10 of the Annex), the fee for submission of Periodic Safety Update Reports (PSURs) for Veterinary Medicinal Products (VMP) varies according the type of authorization procedure (Strictly National or Mutual Recognition/Decentralized) or the PSUR evaluation procedure (PSUR WorkSharing Project – point 11 of the Annex).

We would like to take your attention, namely, for the following changes:

- Change of the fee calculation for PSURs concerning more than one dosage of the same VMP, which is no more based on the marketing authorization number (... *para cada medicamento veterinário, independentemente do número de autorização concedido* = ... for each VMP, independently of the MA number);
- And the species number is no more relevant to the fee calculation for each PSURs.

The validation of the submission is made only on receipt of the detailed calculation on the total fee paid and the proof of payment by each PSUR.

The bank charges are borne by the applicant. If it is not credited the correct amount (rounding - up or down - are not acceptable), the submission will be invalidated.

- 1 Diluent

**PSUR submission fee:**

- 6-month or Annual report:  $150 \text{ €} + 25 \text{ €} + 25 \text{ €} = 200 \text{ €}$
- Triennial report:  $1000 \text{ €} + 150 \text{ €} + 150 \text{ €} = 1\ 300 \text{ €}$

**Example 8**

With:

- 4 Dosages forms
- 1 Pharmaceutical form
- 1 Diluent

**PSUR submission fee:**

- 6-month or Annual report:  $150 \text{ €} + 25 \text{ €} + 25 \text{ €} + 25 \text{ €} = 225 \text{ €}$
- Triennial report:  $1000 \text{ €} + 150 \text{ €} + 150 \text{ €} + 150 \text{ €} = 1\ 450 \text{ €}$

- 1 Pharmaceutical form
- 1 Diluent

**PSUR submission fee:**

- 6-month or Annual report:  $150 \text{ €} + 25 \text{ €} = 175 \text{ €}$
- Triennial report:  $1000 \text{ €} + 150 \text{ €} = 1 150 \text{ €}$
- 5-years report:  $1 500 \text{ €} + 150 \text{ €} = 1 650 \text{ €}$

With:

- 3 Dosages forms
- 1 Pharmaceutical form
- 1 Diluent

**PSUR submission fee:**

- 6-month or Annual report:  $150 \text{ €} + 25 \text{ €} + 25 \text{ €} = 200 \text{ €}$
- Triennial report:  $1000 \text{ €} + 150 \text{ €} + 150 \text{ €} = 1 300 \text{ €}$
- 5-years report:  $1 500 \text{ €} + 150 \text{ €} + 150 \text{ €} = 1 800 \text{ €}$

**Example 16**

With:

- 4 Dosages forms
- 1 Pharmaceutical form
- 1 Diluent

**PSUR submission fee:**

- 6-month or Annual report:  $150 \text{ €} + 25 \text{ €} + 25 \text{ €} + 25 \text{ €} = 225 \text{ €}$
- Triennial report:  $1000 \text{ €} + 150 \text{ €} + 150 \text{ €} + 150 \text{ €} = 1 450 \text{ €}$
- 5-years report:  $1 500 \text{ €} + 150 \text{ €} + 150 \text{ €} + 150 \text{ €} = 1 950 \text{ €}$
